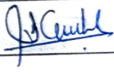

- Five levels of descriptors such as professional, theoretical knowledge, technical skill, employment readiness, learning outcomes will be included.
- It was also discussed with respect to minimum skill qualification will be included in the syllabus.
- The content related to vocational education / skill will be included in the syllabus.
