Resolution: No feedback from stakeholders was received so no discussion took place.

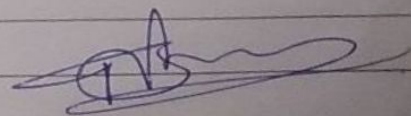
Item 5: To discuss guidelines of OJT/ internship & Research Project for PG.
